- Name Peddie School as a beneficiary of your IRA, 401(k) or other qualified plan. Be sure to use the beneficiary designation form (not your will).
- Designate Peddie School to receive all or a portion of the balance in your plan.
- After your passing, the balance in your plan comes to Peddie School, and we use it to accomplish the mission you believe in.
